What is the difference between Associate and Stockholder?

Stockholders are eligible for the Vendor Rebate, Manufacturer Rebate and Pepsi Rebate.

Associates are eligible for the Manufacturer Rebate and Pepsi Rebate (not the Vendor Rebate).

New members join for free as an Associate member. On December 31, all Associate members who accrued more than \$500.00 in Vendor Rebates and has purchased over \$100,000 from our partner distributors, will be automatically promoted to Stockholder. We will deduct \$500.00 from their Vendor Rebate to purchase one share of stock. At termination, the member is refunded the \$500.00 and the stock is voided. Members who were moved up will have Stockholder status retroactively to the beginning of the year.

Associate Member Limited Benefits

The Associate Member hereby expressly agrees and acknowledges that the only benefits, rights and privileges associated with the Associate Membership in the Cooperative are (a) the right to purchase food, food service commodities and related services at the prices and under the terms set under the Cooperative-purveyor agreements; and (b) the right to receive any direct manufacturer's rebates that are paid with respect to the Associate Member's product purchases from participating manufacturers if and to the extent the Cooperative continues to participate in manufacturer direct rebate programs. The Associate Member further agrees and acknowledges that the Cooperative may earn additional commissions, rebates or fees from the purveyors of food and food service commodities and related services as a result of purchases that may be made by the Associate Member from such purveyors. The Associate Member agrees and acknowledges that in its capacity as an Associate Member of the Cooperative that the Associate Member shall have no right, whether present, future or contingent, to participate in, receive any distribution of or otherwise share in any purveyor rebate, commission or other fee earned with respect to or based on purchases made by the Associate Member, whether in the form of patronage dividends, ordinary dividends, liquidation distributions or otherwise. By execution of this Agreement, the Associate Member does hereby forever release the Cooperative and agrees to hold the Cooperative harmless from any claim by the Associate Member, its successors, heirs or assigns (a) for or to any share of any commissions, rebates or similar payments earned or received by the Cooperative as a result of purchases of licensed purveyor products or services by the Associate Member and/or (b) with respect to any act or omission of any purveyor of products or services licensed or recommended by the Cooperative and/or with respect to the products or services provided by any such licensed purveyor.
